The project was led with an approach that included well facilitated stakeholder engagement, a detailed site inspection, a thorough risk assessment, comparison to international industry benchmarks and best practices, compliance with the Ministry of Health and Wellness guidelines, development of plans with mitigating actions, assignment of responsibilities and accountability to ensure all actions can be implemented before Race Day scheduled June 13, 2020. Project management templates for 28 locations/scenarios were completed and a slide pack with pictures and actions to support Communication and Training of all parties for race Day and non-Race Day were completed and can be accessed.

The following items can now be confirmed by the Project team as being assessed for implementation in the plan before Race Day:

They will secure restricted areas and monitor compliance with mandatory masking requirements. Training for these functions will be covered in Risk communication, Training, and Education with Orientation for Race Day for ALL with COVID-19 operational/procedural responsibilities.
